## **RFC Aircraft Flight Agreement**

Club: Rockwell Flying Club, Inc. The following conditions shall apply to each flight made by the member whose signature appears below in aircraft owned by the Club:

- 1) I will make a pre-flight inspection of the aircraft according to the prescribed procedure as outlined in the approved aircraft manual and will not accept the aircraft until I am satisfied as to its airworthiness and proper functioning of said aircraft including its equipment and accessories.
- 2) I will observe all Federal, State, and local air regulations
- 3) I will use the aircraft only for purpose and over the route specified for each flight as noted in the flight plan covering the flight, which shall become part of the agreement for each individual flight.
- 4) I will return the aircraft at the agreed time, weather permitting.
- 5) I will fly from the left seat only, unless otherwise authorized by club representative.
- 6) I will land only at established airports except as a precautionary or emergency measure.
- 7) I agree to report all accidents, major or minor to the Club General Manager and Aircraft Maintenance Officer at once, together with names and addresses of witnesses and involved parties. I will not allow any damaged aircraft to be moved unless authorized by Club representative.
- 8) I agree not to tamper with or attempt to repair any part of the aircraft or its equipment, but will telephone the Aircraft Maintenance Officer for instructions.
- 9) I agree to pay the club for any losses covered in Article VI of the Club By-Laws.
- 10) I agree to abide by Club By-Laws and Rules and Procedures
- 11) I agree to pay the current established charges for operating club aircraft.
